Remove the option for developers to buy out.**

**Simply put we need affordable housing. In rural district like our own we need to revise existing bylaws restricting the possibility of "tiny homes". Currently the primary dwelling for a single family unit must be 950 sq ft at a minimum in rural HRM. That simply does not allow for affordable housing out here.**

**Yes. In district 2 we don't have those safe spaces to walk nearly at all. We need sidewalks and crosswalks in our high traffic communities, and this is where I will advocate and collaborate with the provincial government. We also as I mentioned early need more green space opportunities.**

**Yes. This is a great sustainable option. We also need to expand transit service throughout more of district 2. **Yes - The best balance sheet in the world doesn't matter on a dead planet. We have to do our share.**

2. As a councillor, what are two motions you would bring forward to advance a just and green recovery in HRM?

**I'm not sure what specific motions I might advance. I have a track record of not being shy about intervening when needed, be it Blue Mountain Birch Cove, funding for urban forestry, HalifACT or the Integrated Mobility Plan. My environmental priorities are to see HalifACT taken seriously as budget funding, to take action on restoring and protecting urban lakes, daylighting the Sawmill River, and to continue the work of making our transportation system more sustainable.**

3. African Nova Scotian, Mi'kmaw and newcomer communities have historically been left out of city planning processes. How will you make sure that the voices and concerns of these communities are heard and prioritized in council decisions?

**We have to do better in involving traditionally marginalized voices. Greater involvement from HRM's African Nova Scotia Integration Affairs Office would be beneficial (the infrastructure is there). The Centre Plan is an example of taking the extra effort to go meet people where they are in the work that was done to engage with the Black community and is a good template for future planning exercises in this area. The Cornwallis Panel was a great success in involving Mi'kmaq voices and seeing through its recommendations is important. That nation-to-municipality panel could be a useful approach for future decision-making in areas where there is a great deal of Mi'kmaq interest.**

4. The full implementation of the Halifax Green Network Plan (HGPN) requires zoning-based tools to protect important greenspace and wildlife corridors and using the HGPN to guide the region's growth. Will you support the full implementation of the HGPN to protect the Green Network? Explain why or why not (optional)

**Yes - We can't continue to sprawl ever outward. The Green Network Plan isn't about restricting traditional rural life or rural towns/villages, it's about preserving the most important places and ensuring that suburban sprawl doesn't continue ever outward.**

5. Halifax's vacancy rate is at an all-time low, 1%, and the average rents have increased by 3.8% from the previous year. Many have declared this a housing crisis that all levels of government must act on. A number of actions are needed to tackle this crisis. As a first step, are you committed to introducing municipal regulations to limit short-term rentals and collaborating with the federal government to increase affordable housing stock? What else would you do? (optional)

**Yes - Short-term rentals, to me, should be limited to a person's primary resident. It's deeply problematic to have existing apartment buildings converted to short-term rentals. It displaces housings and amounts to a hotel operating in a residential neighbourhood. HRM won't solve housing by itself, but I believe we can make a significant contribution through the creation of the new housing fund that will assist non-profits who are active in the housing space. A similar approach in Saskatoon generated just over 2,700 units over the last five years. I think we can do the same here.**

6. Do you support increased spending that supports safer spaces to walk, bike and roll in HRM? Explain why or why not (optional)

**Yes - I'm fully committed to the Integrated Mobility Plan. We won't meet any of our Climate Change or planning goals if we don't shift more people towards biking, walking, and transit.**

7. Are you committed to completing the proposed Bus Rapid Transit network and electrifying 50% of Halifax Transit's fleet to electric by 2028? Explain why or why not (optional)

**Yes - I'm committed to it, but we can't afford it by ourselves, or at least not at the pace that's planned. We need the Provincial and federal governments to come aboard with funding. The infrastructure dollars are, in theory, there.**

8. What will you do to ensure collaboration with communities and underrepresented groups in sustainable and active transportation infrastructure development?

**I'm always open to ideas. Right now we're very much in implementation mode for projects like our rapid transit plan, like the minimum grid. No plan is ever done though and I'm open**

to advancing changes when the community identifies a need. An example that comes to mind is the work I have been doing to try and preserve the pathway connection from Lynn Drive to Regency Drive in my district (a low-income neighbourhood with traditionally low levels of engagement)

9. What would you do to improve the safety of HRM's roads, and ensure the implementation of the Strategic Road Safety Plan? <https://www.halifax.ca/sites/default/files/documents/city-hall/regional-council/180717rc1422.pdf>

**HRM spends nearly \$30 million a year on road recapitalization. That's a large pot of money to work with. I will continue to apply a complete street lens to all projects. Through my advocacy over the last four years, Chadwick Street got a sidewalk by narrowing the road (something that HRM would normally not consider), Sinclair's sidewalk was extended, and Prince Albert's paving project became a road redesign that will dramatically reduce the paved area and make the street safer. It will take a long time to fix 50 years of car centric infrastructure. I'm keen to see HRM's Tactical Urbanism program expand so that we can advance design interventions at a quicker pace. I have been pleased with the project that has already happened in District 5 and I'm enthusiastic about the two that are tendered (Oakdale and Ochterloney/Victoria) and will be put in place this year.**

10. Will you advocate to use municipal funds to buy land for parks at the three key wild spaces identified in the Halifax Green Network Plan: Blue Mountain – Birch Cove Lakes, the Purcells Cove Backlands, and Sandy Lake – Sackville River? Explain why or why not (optional)

**Yes - Yes. Protecting key wilderness areas provides long-term benefit. It's hard to think of Dartmouth without Shubie Park, a purchase that seemed expensive back in the early 1990s. This Council has had a great track record of acquiring lands in Blue Mountain Birch Cove and at Purcells Cove. I'm committed to acting on future opportunities as they arise.**

Halifax and Winnipeg are the only major cities in Canada that do not delivery housing on behalf of the province.**

6. Do you support increased spending that supports safer spaces to walk, bike and roll in HRM? Explain why or why not (optional)

**Yes - We need to connect the funded Regional Centre AAA network better to the suburbs, and finish some other major projects like Bedford Highway AT trail and the Dartmouth Waterfront connector.**

7. Are you committed to completing the proposed Bus Rapid Transit network and electrifying 50% of Halifax Transit's fleet to electric by 2028? Explain why or why not (optional)

**Yes - It is essential to our GHG targets, and the technology has matured so a depot charging model will work for at least 80% of Transits routes, and at the rate ranges are growing, it should be 100% by 2028. The quality of life improvements in terms of noise and stink is just icing on the cake.**

8. What will you do to ensure collaboration with communities and underrepresented groups in sustainable and active transportation infrastructure development?

**The Office of Diversity and Inclusion will play an important role in both guiding staff and providing the training and development to ensure staff have the competencies to engage these communities. ## **Jen Powley's Survey Response**

1. Will you prioritize spending to achieve HalifACT 2050 action plan to reduce HRM's GHG emissions by 75% by 2030 in order to do our fair share and remain below 1.5 degrees of warming? Explain why or why not (optional)

**Yes - I found HalifACT2050 to be insufficient. I do not believe we need to wait until 2030 to demand net zero buildings. If Montreal, Toronto and Vancouver can do it now, why can't Halifax? I also want an account of the carbon emissions in all proposed projects, both upfront emissions (that is, in the building materials) and those due to construction, to be identified in staff reports as a percentage of HRM's yearly carbon budget. HRM needs to ask the province for control of demolition. If we are serious about changing we need to get a handle on the destruction. The document put out by architects declare.com is great. I want HRM to take carbon budgeting seriously, so that we make decisions on what we choose to build with its effect on the climate in mind.**

2. As a councillor, what are two motions you would bring forward to advance a just and green recovery in HRM?

**I would propose that the net zero buildings that HalifACT2050 doesn't require until 2030 be moved up to be required now.**

**The second motion would be to add a line to all staff reports reporting carbon emissions, both embodied and from construction. We will also need to have yearly independent audits of our carbon budgets. I'm not exactly sure how this should happen (maybe readers will have some ideas!), but I do know that we need to do it.**

3. African Nova Scotian, Mi'kmaw and newcomer communities have historically been left out of city planning processes. How will you make sure that the voices and concerns of these communities are heard and prioritized in council decisions?

**I think you forgot persons with disabilities. I want to have an Advisory Committee advising me from a variety of perspectives. This Committee will include African-Nova Scotian and Indigenous leaders, leaders from the communities of persons with disabilities, the Blind, the Deaf, recent immigrants, the 2SLGBTQI+ communities, as well as students, low-income earners and members of the arts communities. If each member of council would commit to doing the same, then a variety of perspectives will be heard, and it will be good for the whole of HRM in terms of democracy and representation. HRM staff should also be consulting similar committees when they write reports. I think it would be great if we had Advisory Committees in all the districts, and then the council could choose, say, two (or more) of those Committees that staff would have to consult when writing each of their reports. They'd be different each time, and could be chosen for relevance to a report, or representation of the views across HRM.**

4. The full implementation of the Halifax Green Network Plan (HGPN) requires zoning-based tools to protect important greenspace and wildlife corridors and using the HGPN to guide the region's growth. Will you support the full implementation of the HGPN to protect the Green Network? Explain why or why not (optional)

**Of course, I would. I developed the original green belt maps for Our HRM Alliance and I brought together 49 of the now 60 groups in the Alliance. The green network plan is based in science and is rational. It is supported by rural, suburban and urban groups.**

5. Halifax's vacancy rate is at an all-time low, 1%, and the average rents have increased by 3.8% from the previous year. Many have declared this a housing crisis that all levels of government must act on. A number of actions are needed to tackle this crisis. As a first step, are you committed to introducing municipal regulations to limit short-term rentals and collaborating with the federal government to increase affordable housing stock? What else would you do? (optional)

**Yes - I think HRM needs to establish an office of non-market housing right away. I think that office should commission and provide plans for a number of Granny suites, all energy-efficient, affordable to build and incorporating Universal design principles for maximum accessibility. HRM could provide snow clearing to these buildings, as they are already clearing the sidewalks. Rather than selling city land to private developers, we should be using it to build affordable housing. We need not just to ask, but rather insist that the province provide HRM with the power to have inclusionary zoning. We have gotten no results from asking**

6. Do you support increased spending that supports safer spaces to walk, bike and roll in HRM? Explain why or why not (optional)

**Yes - There are a series of public green spaces in the South End. They need to be connected through protected bike lanes that do not jeopardize disabled parking. There need to be adequate sidewalks, crossings and curb cuts so that wheelchair users can access those green spaces. I am currently learning the intricacies of signalized intersections because I believe all citizens need a safe place to travel. I was investigating why auditory signals are not available at all intersections. I am now trying to learn why right turns for cars are allowed on red lights. It is disturbing to learn how much car culture has influenced what we see as normal.**

7. Are you committed to completing the proposed Bus Rapid Transit network and electrifying 50% of Halifax Transit's fleet to electric by 2028? Explain why or why not (optional)

**Yes - As a former member of the transportation team at the Ecology Action Center, I am fully in support of transit. I propose in my platform to make transit free as a way of getting private automobiles off the road. Metro transit will be expected to provide better service. Moving to electric buses will be a huge expense and we will need to mitigate their silence so they are detectable to people who are blind. There are federal infrastructure programmes that can help offset the cost. HRM has developed a Green Mobility strategy. This must be implemented and supported.**

8. What will you do to ensure collaboration with communities and underrepresented groups in sustainable and active transportation infrastructure development?

**I think it is crucial to get all members of the community on board. I think the underrepresented groups probably have the most to gain from universal transit but at the same time not knowing their history I do not know the experience they may have had with government practices.**

**People may need help in learning to trust the system. I am committed to making transit free. I have a commitment to a community input panel that would meet once a month to advise me. This group would consist of voices representing a variety of different groups.**

**I think the Road Safety Plan with its dependence on actual data is really robust. I think all I could do as a councilor would be to ensure it is properly financed and respected.**

**Yes - These are places that have been identified by both science and the community as being critical for the health of the environment and the community. I think HRM needs to recognize the value of these places. It may not have a price tag from the development community or it might. In any case its value is priceless.**

**Yes - While "short-term rentals" is a great stepping stone to the affordable housing crisis, this in my opinion is not the answer. ## Virginia Hinch's Survey Response

1. Will you prioritize spending to achieve HalifACT 2050 action plan to reduce HRM's GHG emissions by 75% by 2030 in order to do our fair share and remain below 1.5 degrees of warming? Explain why or why not (optional)

**Yes - We can't afford not to.**

2. As a councillor, what are two motions you would bring forward to advance a just and green recovery in HRM?

**I'd motion that new developments must be planned through a community benefit framework and that they prioritize environmental considerations.**

**I'd also move that a residential and commercial property retrofit program be explored. HalifACT 2050 identified this as a leading mitigator for carbon emissions as well as the most impactful employment consideration.**

3. African Nova Scotian, Mi'kmaw and newcomer communities have historically been left out of city planning processes. How will you make sure that the voices and concerns of these communities are heard and prioritized in council decisions?

**I've lived these exclusions and know how harmful they are. True and meaningful engagement has to occur before all projects and developments that significantly impact our community. The city has to go to the people to engage them and do so with trusted messengers. Simple 'pop-up' consultations or online surveys do not ensure that those who are historically marginalized are properly heard.**

Will you support the full implementation of the HGPN to protect the Green Network? Explain why or why not (optional)

**Yes – I support the HGPN based on my understanding of it so far but cannot speak to its full implementation yet. It is something I still need to better familiarize myself with and look forward to discussion with groups like EAC to better understand its implications.**

5. Halifax's vacancy rate is at an all-time low, 1%, and the average rents have increased by 3.8% from the previous year. Many have declared this a housing crisis that all levels of government must act on. A number of actions are needed to tackle this crisis. **Yes - Regulating STRs is one step. Ensuring that accessible and affordable housing is actually incorporated into community benefit aspects of new development is also something I believe is necessary. In the immediate term, the city needs to identify properties that can be used as affordable units.**

**Yes - Safe, healthy, and accessible communities is one of my priorities. To date, I don't feel the political will has been there to call for such reductions and responsibility seems to often be passed to the Province without considering (or just ignoring) the influence that the city can have on it..**

**Yes. Greenery is important to people's health and actually also has an appreciable benefit to the economy, so I think there's no good reason to not prioritize it.**

**Yes. My housing plan is to set clear standards for what can be built and where, so we have a transparent system where new constructions being built to code don't have to go through a multi-year approvals limbo. This will help increase the supply of housing overall, and we can fine-tune it with the use of incentives and government support where required to have a healthier, more balanced housing market for the full housing spectrum. Over time, the increased tax base will also help provide more funds to use to combat homelessness and tackle other important priorities.**

6. Do you support increased spending that supports safer spaces to walk, bike and roll in HRM? Explain why or why not (optional)

**Yes. In particular I think it's important that we have sidewalks in communities with lots of families so children can get around without being put at risk. Further, it's a great time to invest in transportation infrastructure because of support from other levels of government and our own need for local and targeted expenditure to help move us out of the recession as quickly as safely possible.**

7. Are you committed to completing the proposed Bus Rapid Transit network and electrifying 50% of Halifax Transit's fleet to electric by 2028? Explain why or why not (optional)

**Yes. If anything I would like to do it faster than by 2028! Electrifying our bus fleet helps save on fuel costs and supports the environment at the same time, so it seems supremely sensible.**

**As in the earlier question, I'd like to make staff more representative of our communities, involve local organizations with decision making, and engage people at a 1 on 1 basis by continuing to canvass after the election. **I want to apply deadlines and accountability to the Road Safety Plan implementation so it's acted on without needless delays. For improving the safety of HRM roads more broadly, I want to continue hearing from district 10 residents about local safety issues, and work with professionals so we can apply effective fixes to hazards and prioritize people's health and safety.**

**Yes. While I'm supportive of land purchases in general, I want to be honest in saying I won't be supporting immediate purchases until the pandemic and recession are over. Right now, I want to prioritize municipal funds for keeping people safe and housed, and getting the local economy back on track so we have the funds available to keep making environmental investments in the future. Unlike, say, building green infrastructure, buying land has almost no short term economic benefit so it makes more sense to me to work on the former for now.**

More involvement from the local government could do a lot to help acquire these benefits without putting as much short term cost or long term risk on the individual, which is a major barrier to solar panel purchases.**

13. Will you ensure that as a municipality, HRM will make funds available for non-profit organizations such as housing cooperatives and shelters to retrofit their existing buildings so that they are net-zero energy ready? Explain why or why not (optional)

**Yes. Since increasing the efficiency of buildings through retrofitting can be expected to bring down long term costs for heating, among other things, the municipality could probably offer very generous loans with negative real interest rates to finance retrofitting. This would be nice because it would support non-profits without costing taxpayers much, and would keep funds available in the long run for other good work.**

**Yes. Efficiency should be something governments strive for at all levels and energy efficiency is no different. More planners with that kind of training could only be a good thing, and it shouldn't be unduly expensive.**

## Stephen Chafe's Survey Response

1. Will you prioritize spending to achieve HalifACT 2050 action plan to reduce HRM's GHG emissions by 75% by 2030 in order to do our fair share and remain below 1.5 degrees of warming? Explain why or why not (optional)

**No. Because I do not believe is achievable in that time frame, and because the plan needs revision to allow for what we need to do if the climate situation worsens.**

**It is no good to have a plan to solve something, if you do not also have a plan to deal with what happens when the first plan fails. To not have a Plan B is to guarantee failure, and usually the worse kind of failure.**

2. As a councillor, what are two motions you would bring forward to advance a just and green recovery in HRM?

**I would like to make a motion to introduce the Solar Thermal Program and the Green House Initiative. Although they are not the only two green programs I would put forward.**

**Start a sister program to the Solar Panel Finance program, which is used for people who want to install Solar Thermal systems in their homes as well. Currently the program is set up mainly for PVC panels, and limited thermal -- but not for the kinds of mixed system that are used in place in Europe.**

**Solar Thermal is a better technology, uses less rare earth minerals, and unlike PVC panels it is a fairly stable technology. It would also be better used for large scale power generation through steam. Also common in places like Germany.**

**The Greenhouse in every backyard program would similar to the old Composter program that was introduced a decade ago. The goal would be to buy at wholesale costs a large number of Greenhouse kits, and make them available to households at a more reasonable cost.**

**The goal is to encourage more local food consumption, less importing of foods, and thus not only food security but also less burning of fossil fuels used to transport food products to our province.**

**A third thing would be providing courses for people to learn how to set up small Solar or Wind generation capacity at home (outside of normal grid use) would also be something I would like to see offered by the city. This would mean setting up Solar PVC stations in home garages or sheds that can be used eventually to power smaller E-vehicles, Scooters, or even single use batteries in the home for some devices not connected to the grid. Emergency cells or battery wall-based kits being part of that solution.**

**A fourth thing would be a seed warehouse and distribution program for urban gardens and also to encourage more home food production and growth options (even hydroponics).**

3. African Nova Scotian, Mi'kmaw and newcomer communities have historically been left out of city planning processes. How will you make sure that the voices and concerns of these communities are heard and prioritized in council decisions?

**If possible (and if those communities welcome it) we should have public townhalls in their respective communities. To make attending such sessions as easy as possible.**

**Sending out direct surveys to members of these communities, and conducting follow-up phone calls would seem a wise step for data collection analysts to follow as well.**

4. The full implementation of the Halifax Green Network Plan (HGPN) requires zoning-based tools to protect important greenspace and wildlife corridors and using the HGPN to guide the region's growth. Will you support the full implementation of the HGPN to protect the Green Network? Explain why or why not (optional)

**Yes. Green space is a future need, not just a current need.**

5. Halifax's vacancy rate is at an all-time low, 1%, and the average rents have increased by 3.8% from the previous year. Many have declared this a housing crisis that all levels of government must act on. A number of actions are needed to tackle this crisis. As a first step, are you committed to introducing municipal regulations to limit short-term rentals and collaborating with the federal government to increase affordable housing stock? What else would you do? (optional)

**Yes. I plan to push for Affordability Indexing, which will allow landlords to rent for less than average market value, and take the equivalent different off the property taxes they have to pay.**

**If combined with a similar Federal program (effecting Tax on Rental Income) should greatly reduce the options of affordable rentals, along with putting downward pressure on existing market prices. Thus, curbing some of the extreme rental increases the greediest of landlords seek.**

**This will immediately provide the option for lower rents in at least 5% of the available rental market stock, and hopefully pull some of the short-term rental units back into the market as well -- increasing numbers.**

**I would also like to see a study of converting Commercial spaces or unused Churches and Schools into emergency shelter units.**

6. Do you support increased spending that supports safer spaces to walk, bike and roll in HRM? Explain why or why not (optional)

**Yes. The introduction of the Dual Sidewalk program, which is far more cost effective, safer, and less maintenance then the current use of bike lanes along major arterial roads. This is for the benefit of wheel chair users as well as those who are using E-scooters and the like.**

7. Are you committed to completing the proposed Bus Rapid Transit network and electrifying 50% of Halifax Transit's fleet to electric by 2028? Explain why or why not (optional)

**No. Current costs for rolling stock are too high for our current city budgets, and the technology is not quite there yet.**

I think that is partially due to the lack of service in rural areas. Having empty busses running 100% routes throughout the covid-19 pandemic, and an estimate revenue loss off \$20 million, has put an incredible strain on our City's budget for 2021. We can help offset this by following other major cities examples and increase our Metro-X routes to key tourist locations such as beaches and parks outside the peninsula. Transit revenue would increase throughout late spring- to early fall, as it gives tourists, students, and/or peninsula residents the ability to access beaches outside the city without driving. It's an important revenue source.**

**Yes. We were one of the first cities in Canada to declare a climate emergency and I advocated strongly for HalifACT to be adopted and to be challenging. Our staff has seen the will of Council and produced excellent work. The implementation must be a key priority for the 2020-2024 Mayor and Council. For the protection of our economy in the long term, and the safety of our citizens it is critical that we meet the targets in that plan. That means Council must ensure that the resources are available, and that the necessary partnerships are pursued to ensure the successful implementation of the strategy and that the community embraces its shared responsibility.**

2. As a councillor, what are two motions you would bring forward to advance a just and green recovery in HRM?

3. African Nova Scotian, Mi'kmaw and newcomer communities have historically been left out of city planning processes. How will you make sure that the voices and concerns of these communities are heard and prioritized in council decisions?

**One of the things of which I am most proud has been the creation and establishment of the Office of Diversity and Inclusion. Together, with community leaders and partners, they are helping us become a more welcoming and inclusive municipality. Some of our inclusion initiatives are:**

- **Drafting and implementing of the new 3-year Immigration Strategy, inclusive of public feedback.**

- **Working with the Local Immigration Partnership to enhance collaborations among services agencies, the community, and the municipality.**

**I believe we must build upon the work done in these offices to strengthen the voice of members of minority groups in the decisions made by Council and within HRM.**

**I would also help ensure that our leadership represents the municipality's diversity through the establishment of an Inclusion Halifax initiative to actively recruit underrepresented groups to the municipality's agencies, boards, and commissions and to encourage more people from diverse backgrounds to serve on HRM committees of Council and to run for Council.**

**Council recently approved a social policy lens that will allow us to more broadly consider these issues. For example, it will be applied in the context of traditional African Nova Scotian and Mi'kmaw communities as we move to the procurement phase of the Cogswell district project.**

4. The full implementation of the Halifax Green Network Plan (HGNP) requires zoning-based tools to protect important greenspace and wildlife corridors and using the HGNP to guide the region's growth. Will you support the full implementation of the HGNP to protect the Green Network? Explain why or why not (optional)

**Yes. COVID has demonstrated how important our green spaces are to our health as a community, as well as for the physical, emotional, and mental health of individuals and families. I was proud to support the purchase of lands to expand the Blue Mountain-Birch Cove Lakes holdings and the Purcell Cove Backlands. I believe that, in addition to their intrinsic value as part of our environmental protection and climate change mitigation efforts, these lands are an important part of our ability to attract business and professionals who look for quality of life in making their decisions.**

5. Halifax's vacancy rate is at an all-time low, 1%, and the average rents have increased by 3.8% from the previous year. Many have declared this a housing crisis that all levels of government must act on. A number of actions are needed to tackle this crisis. As a first step, are you committed to introducing municipal regulations to limit short-term rentals and collaborating with the federal government to increase affordable housing stock? What else would you do? (optional)

**Yes. Council has already moved to reduce short-term rentals and will adhere to the provincial regulations. I'm also committed to creating a Housing Trust, funded by developers, that will allow the municipality to work with not-for-profits and leverage federal housing funds to develop affordable housing. I also believe we can move to additional incentives, such as waiving development fees, for the creation of new affordable housing. We also need to find ways to work with the province and other partners to ensure affordable housing in**

**communities across the municipality, to allow seniors to age in their own communities, to provide greater options for differing family sizes, and to allow more co-housing options.**

6. Do you support increased spending that supports safer spaces to walk, bike and roll in HRM? Explain why or why not (optional)

**Yes. I believe that our environmental goals, as well as healthy living, are supported by active transportation. That's why I support the \$25 million investment in safe bike lanes: not for the people who are biking today, but for the people who will be biking in the next five years. The council-approved Integrated Mobility Plan is clear that we must shift to more personal transportation through more environmentally-friendly means, i.e. active transportation and transit. This is an ambitious plan that will require significant municipal resources and require us to take full advantage of federal and municipal funding sources.**

7. Are you committed to completing the proposed Bus Rapid Transit network and electrifying 50% of Halifax Transit's fleet to electric by 2028? Explain why or why not (optional)

**Yes. I believe Climate Change is one of the most critical issues facing us and we cannot meet the goals of HalifACT without these changes. This is one way that the municipality can encourage higher transit use, reduce our emissions, and demonstrate leadership in combatting climate change.**

**As we move to further consultation on these initiatives we should, for a start, use the newly adopted social policy lens on our consultation and decision-making. I would also support working with the Diversity and Inclusion division of HRM on outreach and engagement with under-represented communities.**

**Yes. Few things are so frightening as the prospect of insufficient food for your family. Yet, it is estimated that as many as 1 in 5 households in Halifax experience food insecurity. The pandemic has only heightened the risk of food insecurity for residents.**

**My office has long had representation at the Food Policy Alliance table and my office has taken a lead role in the establishment and ongoing work of the Mobile Food Market. Indeed, food security has been a significant plank of the healthy community priority focus I brought to Council in my first term.**

**In the past few years, HRM has played a growing role in supporting community food security through its involvement in the Mobile Food Market, a direct initiative of my office, and in the more than 20 community gardens on municipal land. Social enterprises such as Hope Blooms, Common Roots farm, and Dartmouth's North Grove demonstrate daily what is possible to achieve when bright minds and willing hearts convene to grow and share food.**

**Both the municipal Public Safety Strategy and the Building Poverty Solutions Strategy include a focus on food. Recently, Halifax was selected by the McConnell Foundation as one of the three Participatory Cities in Canada, bringing another food-access focus to the municipality, working with my office, the Mi'kmaw Native Friendship Centre, the United Way, Develop Nova Scotia, and others.**

**In December 2019, Halifax Regional Council unanimously passed a motion committing to working with the Halifax Food Policy Alliance on the creation of a Food Action Plan to help fight food insecurity throughout the Halifax region.**

**I believe we must:**

- **Explore the possibility of a community food hub to allow for better and more efficient distribution of community food.**

- Create a new HRM food policy staff position to lead the municipality's food work and ensure alignment with internal and external stakeholders.
- Make food security a continued priority area for the 2020-24 term.
- Continue to support the Mobile Food Market project through in-kind and direct financial assistance.
- Ensure the timely completion of the HRM/Halifax Food Policy Alliance Food Action Plan.
- Explore new zoning options that would allow for increased food production on residential land for sale at local food markets to meet needs at the neighbourhood level.

**Yes, on a positive recommendation from staff with appropriate expertise**
